- Jodi Oliver (Clark):
  - o Jodi shared that she has learned a lot from being on the Council and is available as a resource within our community if needed.
- Norma Pickett (Skamania):
  - o Norma is retiring and will be moving to Arizona. Date to be determined.
- Mary Repar (Skamania):
  - Mary shared her continued concerns about Skamania County Senior Services cook and funding.
    - Christina advised that the concerns have been met and have been funded by AAADSW.
  - Stevenson Elementary School has closed.
  - Expressed an interest in education surrounding scams that seniors see and how to recognize and avoid them.

#### Reports:

<u>Executive Director's Report</u>: Mike thanked everyone for sharing what is going on in their local communities and sharing ideas with each other on possible solutions. He appreciates the advocacy and the commitment to older adults and individuals with disabilities in their communities.

- Direct Care Workforce Development:
  - Mike reached out to Ric Palmer (Wahkiakum School District).
    - Waiting for a response.
  - o Mike reached out to Dave Blanchard (Cascadia Tech).
    - Waiting for a response.
  - Vickie Hrdina ESD 112 Rural Coop
    - The plan is to still have the course offered for January 2025.
- ➤ W4A:
  - Working on 2025 Legislative Priorities
    - Funding for Senior Nutrition
      - Total ask is \$35.5M.
        - Increases state-funded senior nutrition by \$32.1m for biennium.
        - Also increases Medicaid rate for home delivered meals for \$3.2m (\$1.6m GFS).
    - Funding for Case Management
      - Decreases case ratio from 1:75 to 1:72.
      - Increases HCS FTE by increasing assessment time from 5.7 hours per client to 6.7 hours.
      - \$21m (\$10.9m GFS) biennial request.
        - o Of the request, \$9.9m (\$4.9m GFS) is for AAAs
    - WA CARES:
      - Total request is for \$145m for biennium for WA Cares Operations.
        - o Includes \$27.3m for AAA operations for biennium.
- HCS Assessment back log
  - o Region 1 is 2 -3 months out
    - Includes Klickitat County
  - o Region 2 is 3 months out
  - o Region 3 is 45 days out
    - Includes Clark, Cowlitz, Wahkiakum and Skamania Counties

- o Mike shared his appreciation to Jodi Oliver for her service on the Advisory Council.
- Staffing AAADSW management is working on ways to increase staff retention.
